**NOW THEREFORE BE IT RESOLVED**, that the Town Council hereby approves the bid, quote or proposal of Value Dry of Savage, Maryland entitled Attachment #2 regarding 606 Modoc Lane waterproofing amounting to the discounted cost of \$6,287.00 (discounted), attached hereto & incorporated herein;

**AND BE IT FURTHER RESOLVED**, the Town Council hereby approves the bid, quote or proposal of Value Dry of Savage, Maryland entitled Attachment #2 regarding Arapahoe Drive two (2) garage bays waterproofing amounting to \$8,963.00 (discounted);


**AND BE IT FURTHER RESOLVED**, that prior to the Mayor signing the approved proposals of Value Dry of Savage, Maryland said company shall provide a certificate of good standing and proof of insurance indemnifying the Town, to the satisfaction of the Town Administrator; and

**BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately upon passage.


