

RESOLUTION 42 -14
THE TOWN OF FOREST HEIGHTS

AN AMENDMENT TO RESOLUTION 82-13 AUTHORIZING AN ADDITIONAL COST OF \$25,835.50 FOR ASPHALT & CURB AND STREET REPLACEMENT SERVICES FOR SENECA DRIVE & MODOC/MILES DRIVE INTERSECTION.

WHEREAS, the Town Council has authority to approve contracts and procurements pursuant to the Town Charter, Section 33-63, and Town Code, Section 20.4; and

WHEREAS, the Public Works Supervisor has obtained competitive bids or proposals from Choice Concrete Const., CAM Services, Inc., and KC Delivery Service General Contracting, LLC; and

WHEREAS, in the process of repairing the curb and curb pan along a significant section of Seneca Drive the Town encountered several additional issues that need to be address; and

WHEREAS, the slope of the street itself did not allow for the water to drain properly to the curb thus, it was necessary to further process the slope of the street; and

WHEREAS, it was necessary to adjust the height of the curb in order to decrease the possibility of cars jumping the curb; and

WHEREAS, it was necessary to repair the driveways that were damaged removing some broken curb pans; and

WHEREAS, the contractor encountered a number of asphalt layers that improperly performed and in order to perform the original contract, it was necessary to reconstruct half of the street which necessitated cost overruns in the amount of \$25,835.50.

NOW THEREFORE BE IT RESOLVED, that the Town Council hereby approves the additional cost of \$25,835.50.

AND BE IT FURTHER RESOLVED, that the Town Council hereby approves the additional cost of \$25,835.50.

AND BE IT FURTHER RESOLVED, that consideration for the above contract shall be appropriated and paid for from Line Item 8000 of the FY2014 Budget; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
