**A RESOLUTION TO TRANSFER FUNDS BETWEEN APPROPRIATIONS IN  
FY 2015 BUDGET**

**ENACTED:**

**WHEREAS**, Section 33-46 of the Charter of the Town of Forest Heights states that no money may be expended without having been appropriated by the Council; and

**WHEREAS**, Section 33-47 of the Charter of the Town of Forest Heights states that any transfer of funds between major appropriations for different purposes by the Mayor must be approved by the Council before becoming effective; and

**WHEREAS**, Section 33-48 of the Charter of the Town of Forest Heights forbids the over expenditure of appropriated or transferred funds; and

**NOW, BE IT RESOLVED**, that line item 6107 Kaboom Grant be added to the Revenue section of the budget in the amount of \$20,000 and that line item 8039 Kaboom Grant be added to the Expense section of the budget in the amount of \$20,000 , that funds be transferred from line item 8033 Forest Heights Sustainable CDC in the amount of \$9,500 to line item 8000 Street Repair Project in the amount of \$5,000, to line item 7224 Training – Administrative Assistant in the amount of \$1,500, and to line item 7004 Salary - Mayor in the amount of \$3,000, from line item Legal Services in the amount of \$4,000 to line item 7003 Codification in the amount of \$4000, from line item 7032 Unemployment Compensation in the amount of \$7,000, to line item 7128 Health Insurance in the amount of \$7,000.

**AND BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately upon its passage.
