**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Town Council of the Town of Forest Heights, Maryland hereby ratifies the procurement and authorizes the Mayor to sign the above referenced proposal dated September 4, 2015 (attached hereto and incorporated by reference herein) with Fox Creek Builders, LLC and materials as specified in Exhibit A.
