**A RESOLUTION TO ACCEPT THE ONE-TIME GRANT FROM THE MARYLAND
DEPARTMENT OF TRANSPORTATION FOR THE TOWN OF FOREST HEIGHTS**

WHEREAS, Chapter 310 of the 2015 Laws of Maryland (HB70-Budget Bill for Fiscal Year 2016) allocated a Special Fund appropriation of \$25,000,000 to the Maryland Department of Transportation for the purpose of providing transportation grants to municipal governments; and

WHEREAS, it further provided that these grants are one-time only grants and the funds are to be allocated as provided in Section 8-405 of the Transportation Article (Computation of Highway User Revenues for Municipalities); and

WHEREAS, to be eligible to participate, the municipal government must agree to only expend these grant funds in accordance with Section 8-408 of the Transportation Article (Permitted uses of Highway User Revenues); and

WHEREAS, the Town of Forest Height has submitted the certification of participation in the One-Time Grant Application to the Maryland Department of Transportation on September 13, 2015 and has received \$51,577.65 on October 19, 2015; and

BE IT RESOLVED that the Mayor and Town Council of The Town of Forest Heights, Maryland hereby agrees to accept the One-Time Grant from the Maryland Department of Transportation in the amount of \$51,577.65 for FY2016;

AND BE IT FURTHER RESOLVED that the \$51,577.65 be allocate to line item 6023 Highway User Revenue of the FY2016 Budget;

AND BE IT FURTHER RESOLVED that this Resolution shall take effect upon its passage.
