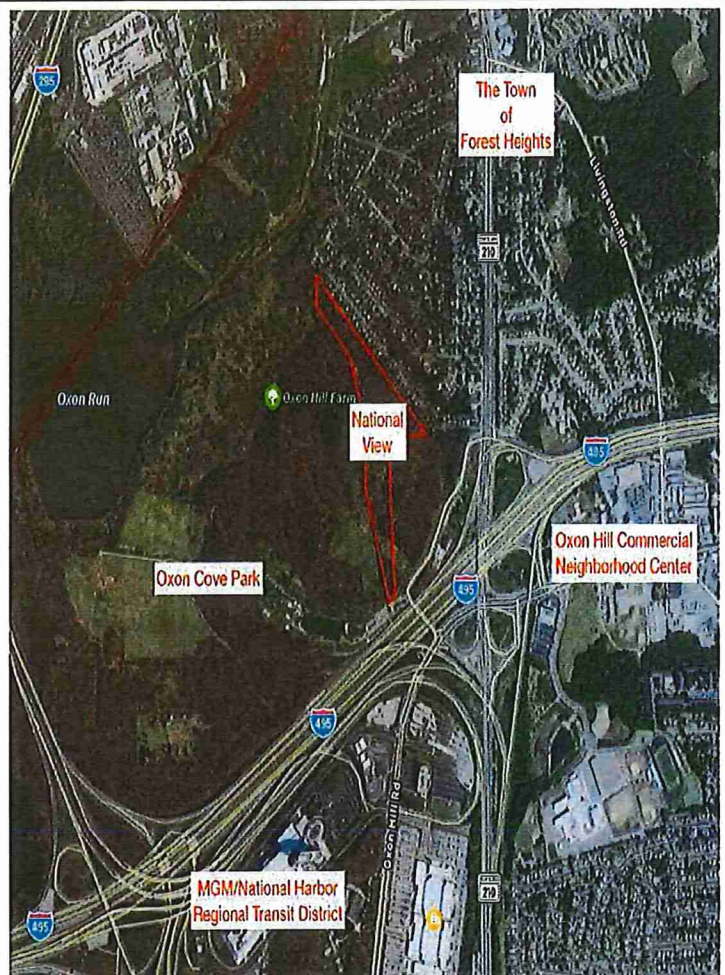

COVID-19 Intervention and Assistance for Town Residents: Forest Heights has aided its citizens with the help of information and Government sponsored Coronavirus Relief Fund financial aid measures.

Enhancements to Police Department for a Safer Forest Heights: We hired the current 13 officer police force (largest staffing in town history) which set the stage for soon to be 24-hour police patrols; procured much needed equipment for officer safety including tasers, body cameras and prisoner transport cages for cars; enhanced the police K-9 program with the creation of 2 K-9 officers.

Infrastructure Repairs and Improvements: The use of \$1,000,000.00 in State Infrastructure Bond funding, has repaired, and will continue to resurface streets based on the order of severity and need of repair.

Grants Programs Supplement Revenue for Town Projects to Lessen Burden on Taxpayers: This administration has heavily utilized Federal, State and Local grant opportunities, funded projects that would otherwise require using taxpayer funds. For example, a new park or "Gathering Space" at Sachem Drive & Seneca Drive complete with public seating, lighting and a gazebo and stage area for small events.

Keeping Taxes Low: Keeping my original campaign promise four years ago, we have managed to provide essential and desired Town services to the citizens my entire time in office without raising YOUR residential property taxes.

Improved relationships with our Federal, State and County Politicians and Representatives: I have placed great emphasis on improving the relationships between the town and our state and local legislators. As a result, some of these officials have sponsored legislation that has provided hundreds of thousands of dollars in government or grant funding to Forest Heights.

Casino Local Impact Funding: Forest Heights now receives a six-figure annual payment from casino revenue which has been guaranteed for decades and included as part of the town budget. These monies also fund projects that would otherwise require using taxpayer funds.

Social Programs, Outreach and Lobbying Efforts. We continue to support programs for our seniors and youth. We have our senior exercise and Healthy Heights seminar programs.

Safer Pedestrian Experience in Forest Heights: A new sidewalk has just been completed along North Huron Drive, partially with Safe Route to School grant funds enabling children to walk safely to Forest Heights Elementary School. Other sidewalk construction is planned this year and for the near future.

Recent Annexations to Forest Heights: While in office over the last several years, I ushered in three annexations which have more than doubled the size of the Forest Heights town limits. They include, Oxon Hill High School, the Oxon Hill Farm and Oxon Hill Manor to name a few. These facilities, amenities and the surrounding lands help provide the town with an enhanced opportunity for future investment, municipal viability, visibility, and potential for an increased economic and tax base.

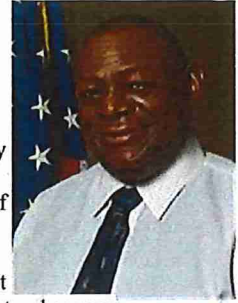

In 1977 after an extensive search throughout the metropolitan area, Larry chose to make Forest Heights his home. This quaint and neighborly community proved to be the perfect place to live and raise his family, daughter Germaine, and sons Larry, Jr. and Larrence. However, once again Dr. King's message of "service" would ring loud in Larry's ears. He heard the call and successfully ran for Councilman in 2003. He was elected and served from 2003 to 2007 as well as a third term from 2012 to 2014. In addition, he served as Council President in 2007. In addition to holding local office, Larry has developed a strong network and the respect of political, business and civic leaders throughout Prince George's County via his continued volunteerism and community advocacy work.
