Charter Amendment Resolution Number 02-23 A Charter Amendment Resolution of the Mayor and Council of the Town of Forest Heights, Maryland to amend section 33-18 (Powers and Duties) of the Charter to require that all subordinate officers and employees of the Police Department of the Town Government shall be appointed and removed by the Town Administrator with the consent of the Mayor, in accordance with rules and regulations of any Merit System which may be adopted by the Council; and to amend Section 33-67 (Merit System) of the Charter to clarify and expound on the power of the council to adopt or delegate such rules and regulations governing the operation of a Merit System, and generally relating to town employees and the Administration of Town Government.

Annexation Resolution No. 01-23 A resolution proposing the annexation of certain real property located generally South of and partially surrounded by the present corporate limits of the Town of Forest Heights extending along, abutting to, and including unimproved property known as National View and formally known as the Butler properties including parcels 26, 27, 32, 33, 35, 36 and 37 situated east of the Oxon Hill Farm and North of the Washington circumferential highway (i-95 & i-495 – Capital Beltway) located at and fronting upon Bald Eagle Road as further depicted on tax map 95, grids f3 and f4 (account no.’s 17-121210731, 17-121210285, 17-121210715, 17-121210707, 17-121210681, 17-12121069) and lands of the Maryland State Roads Commission (“SRC” - part of tract 5-a and part of tract 5-b recorded at liber 2372, folio 613, and part of Butler to SRC recorded at 2516, folio 90 of the land records of Prince George’s County) into the corporate territory of the Town Forest Heights (the tenth extension); and providing for the terms and conditions of the annexation to The Town Of Forest Heights; amending the Charter of the Town of Forest Heights for the purposes of including the annexed property within the legal descriptions and plats depicting the corporate limits of the Town; and generally all matters related to said annexation.
