**A RESOLUTION OF THE MAYOR AND COUNCIL TO PLAN AND AMEND THE
BUDGET FOR THE 75TH ANNIVERSARY OF THE TOWN OF FOREST HEIGHTS**

WHEREAS, the Town was incorporated on April 19, 1949, 75 years ago, and the Mayor and Council wish to recognize the Town's anniversary to strengthen community spirit; and

WHEREAS, the Mayor and Council passed Emergency Ordinance 03-23 on June 9, 2023, approving the Fiscal Year 2023-24 Budget for The Town of Forest Heights (the "Town"); and

WHEREAS, Section 33-46 of the Town Charter requires that no public money may be expended without having been appropriated by the Council; and

WHEREAS, Section 33-48 of the Town Charter requires that during any budget year no officer or employee of Town shall expend or contract to expend any money or incur any liability which by its terms involves the expenditure of money for any purpose, in excess of the amounts appropriated for or transferred to that general classification of expenditure; and

WHEREAS, Opportunities for corporate sponsorships are available, and conversation have been had securing the majority of the event cost. This event is planned to be self-funding so Town will not be utilizing public funds for the event costs.

Now, THEREFORE BE IT RESOLVED, the Town will amend the FY23/24 Budget to account for the receipts and expenditures of the 75th Anniversary incorporating the following changes.

Increase Other Revenues

Budget Line: 6175.1 Sponsors- \$15,000

6175.2 Ticket Sales-

Increase Youth and Community Outreach

9010-8011 Forest Heights 75th Anniversary- \$15,000

BE IT FURTHER RESOLVED, that the Mayor is authorized to enter into vendor contracts and start the event planning.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage. PASSED this __1__ day of April 2024.
