**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST
HEIGHTS ESTABLISHING THE PLACEMENT OF TRAFFIC CONTROL DEVICES
ALONG SACHEM AND CREE DRIVE IN THE TOWN FOREST HEIGHTS**

Introduced By: Mayor Troy Lilly and Councilmember Noble

WHEREAS, the Mayor is authorized pursuant to Section 15.3.A. of the Ordinance Code of the Town of Forest Heights (the "Town") to temporarily erect or cause to be erected any traffic control devices in the Town; and

WHEREAS, in order for the above-referenced temporary placement of a traffic control device to be permanently erected within a Town right-of-way, the Council must pass a resolution giving final approval of said placement or posting; and

WHEREAS, Section 15.3 of said Ordinance Code further mandates that once a sign or traffic control device is so placed, a description of said device shall be placed on a list maintained by the Police Department describing all such traffic control devices erected within the Town; and

NOW THEREFORE BE IT RESOLVED, that the Town Council approves the placement of traffic control devices on Cree and Sachem Drive within the Town of Forest Heights.

Section 1

Sachem Drive: This sign shall be designated for a STOP sign at the intersection of Cree Drive and Sachem Drive.

Section 2

Cree Drive: This sign shall be designated for a STOP sign at the intersection of Sachem Drive and Cree Drive.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
